WHO MAY OBTAIN ACCESS TO PERSONAL DATA AND DO WE TRANSFER IT TO THIRD COUNTIRES.

At each stage of personal data processing we take care of its safety. Therefore, access to personal data connected with providing the Portal service may be given exclusively to:

- 1) our authorized staff and cooperators,
- 2) legal counsel office, in connection with the process of establishing, redressing and defending against claims,
- 3) auditors, in connection with executing their duties in auditing
- 4) entities entitled to obtain information about personal data pursuant to the legal provisions binding in the Republic of Poland.



We do not transfer personal data to Third Countries (outside the European Economic Area) or international organizations.

WHAT RIGHTS MAY BE EXERCISED BY THE PERSON WHOSE DATA IS PROCESSED BY THE CONTROLLER.

By contacting us at: gdpr@drutex.com.pl you may demand the execution of your rights:

- a) access to personal data in the scope specified in the GDPR provisions (art. 15 GDPR),
- b) rectifying data (art. 16 GDPR),
- c) demanding removal of data if one of the premises indicated in GDPR has been fulfilled (art. 17 GDPR),
- d) restricting personal data processing in cases prescribed by GDPR legislation (art. 18 GDPR),
- e) data transferring (art. 20 GDPR),
- f) lodging a complaint with a superior authority, i.e. Inspector General for the Protection of Personal Data (art. 77 GDPR).

What is more, each person whose data is processed for purposes resulting from the Controller's legitimate interest, has the right to lodge an objection against personal data processing due to their particular situation (art. 21 GDPR).

IS SUBMITTING PERSONAL DATA OBLIGATORY

Providing your personal data is voluntary. However, its absence may make it impossible to conclude and execute the loan agreement.

DO WE MAKE DECISIONS IN AN AUTOMATIC WAY WHEN PROCESSING PERSONAL DATA.

We do not apply automatic decision making based in analysis of personal data. The decision to grant the loan is always made by a person authorized by DRUTEX.
