

INFORMATION REGARDING PERSONAL DATA PROCESSING

DISTRIBUTORS OF DRUTEX SA PRODUCTS

Pursuant to Article 13 (1) (2) of Regulation of the European Parliament and the Council (UE) 2016/679 of 27 April 2016 on the protection of individuals with regard to the processing of personal data and on the free movement of such data as well as on the repeal of directive 95/46/WE (general regulation regarding personal data, hereinafter referred to as: "GDPR"), we wish to inform you:

Who is the personal data Controller

The Personal Data Controller is DRUTEX S.A based in Bytów (77-100) in Lęborska 31 street, NIP (tax identification number) 421622720 (. (hereinafter referred to as: Controller or DRUTEX)).

For what purpose and how long we process your personal data.

Purpose	Legal basis	Period of processing
Executing the contract to which DRUTEX and you are a Party.	art. 6 (1) (b) GDPR	Until the contract has expired expanded by warranty period of the producer for the products sold by the distributor.
Executing the contract to which DRUTEX is a Party and your personal data has been indicated as the data of a representative or a contact person with DRUTEX	Art. 6 (1) (f) GDPR	Until the contract has expired prolonged by warranty period of the producer for the products sold by the distributor.
Establishing, redressing and defending against claims that may occur in connection with the Contract.	Art. 6 (1) (f) GDPR	Until limitation period for claims defined by Polish law, including tax law (regarding claims from the State Treasury)
Support in the process of claim proceedings.	Art. 6 (1) (f) GDPR	Proceeding period of the claim.
Establishing, redressing and defending against claims in connection with the lodged complaints.	Art. 6 (1) (f) GDPR	From concluding the complaint until the producer's warranty and claims have expired (period defined by binding laws).
Direct marketing of the Controller's products	Art. 6 (1) (a) GDPR	Until the Contract has been terminated or consent withdrawn, whichever occurs first.

WHO MAY OBTAIN ACCESS TO PERSONAL DATA AND DO WE TRANSFER IT TO THIRD COUNTRIES.

At each stage of personal data processing we take care of its safety. Therefore, access to personal data connected with providing the Portal service may be given exclusively to:

- 1) our authorized staff and cooperators,
- 2) legal counsel office, in connection with the process of establishing, redressing and defending against claims,
- 3) auditors, in connection with executing their duties in auditing
- 4) entities entitled to obtain information about personal data pursuant to the legal provisions binding in the Republic of Poland

We do not transfer personal data to Third Countries (outside the European Economic Area) or international organizations.

WHAT RIGHTS MAY BE EXERCISED BY THE PERSON WHOSE PERSONAL DATA IS PROCESSED BY THE CONTROLLER.

By contacting us at: gdpr@drutex.com.pl you may demand the execution of your rights:

- a) access to personal data in the scope specified in the GDPR provisions (art. 15 GDPR),
- b) rectifying data (art. 16 GDPR),
- c) demanding removal of data if one of the premises indicated in GDPR has been fulfilled (art. 17 GDPR),
- d) restricting personal data processing in cases prescribed by GDPR legislation (art. 18 GDPR),
- e) data transferring (art. 20 GDPR),
- f) lodging a complaint with a superior authority, i.e. Inspector General for the Protection of Personal Data (art. 77 GDPR).

What is more, each person whose data is processed for purposes resulting from the Controller's legitimate interest, has the right to lodge an objection against personal data processing due to their particular situation (art. 21 GDPR).

If you have given your consent to obtain marketing information, we wish to inform you that the consent may be withdrawn at any time.

ARE YOU OBLIGED TO SUBMIT YOUR PERSONAL DATA

Providing your personal data is voluntary. However, it is necessary to execute the order placed by the Client – prepare and execute the Contract, and to obtain trade information and support of the Controller in dealing with the complaint. .

DO WE MAKE DECISIONS IN AN AUTOMATIC WAY WHEN PROCESSING PERSONAL DATA.

We do not apply automatic decision making based in analysis of personal data.
